NOTICE OF RACE



The Combined Clubs Committee; the Host Club; the Organising Authority; the Bermuda Class Associations; the Event Organisers; the Sponsors; their Officers, Members; Employees; and Volunteers, bear no responsibility for accidents, damage or injuries to boats or their crew however so caused during or related to these regattas. Attention is drawn to ISAF RRS 4 (Decision to Race).

Preamble	The "Standard Instructions – One Design" document is to be read with, and forms part of, this Notice of Race.
Invitation	The Organising Authority and the Host Club - The Royal Bermuda Yacht Club (R.B.Y.C.), are pleased to invite sailors to compete in R.B.Y.C. Saturday Fleet Racing for one-design classes.
Eligibility, Entry & Fees	<p>The regatta is open to boats of one-design keelboat classes having a Bermuda Class Association. Proof of insurance, to comply with SI 30.1, shall be required prior to registration being accepted.</p> <p>Registration shall be by delivering a completed entry form, and the registration fee, to the Sailing Office, no later than the day before competing in the first regatta. Boats not registered shall not race and shall not be scored.</p>
Schedule of Races	<p>The regatta schedule shall be as indicated in "Appendix 2 –Schedule (One-Design)". Five races shall be scheduled for each regatta. One race shall be completed to constitute a series.</p> <p>The scheduled time of the warning signal for the first race is 1255 hours on each scheduled race day. No warning signal shall be made after 1630 hours.</p> <p>Starts shall be given for One-design classes having 3 or more boats at the starting area.</p> <p>Races Abandoned or Postponed shall be started as soon as practicable.</p> <p>Races not sailed on the scheduled race day shall be rescheduled to the next free makeup day in the schedule ("CC Reserve"), or, if there is no free makeup day, shall not be rescheduled and shall be scored as void.</p>
Transfer of Ownership	When an owner and/or owning syndicate newly acquires a boat, they shall inform the relevant Bermuda Class Association (BCA) before racing the new boat. In that case, if the same or similar owner and/or owning syndicate previously raced another boat of the same class, the BCA may request the R.B.Y.C. that all points gained by that other boat under that ownership before the change, be transferred to, and aggregated with points gained by the newly acquired boat after the change.
Individual Series	These races are indicated in the Race Schedule as having the Trophy presented by R.B.Y.C.
Scoring	The Low Point scoring system of RRS Appendix A shall apply with no scores excluded
Prizes	Prizes will be awarded to the first boat in each class.
Overall Series	T.F. Cooper Memorial Trophy , the J-24 Half Model , the John Thompson Memorial Trophy , and the Owen Darrell Memorial Trophy are awarded for the overall results for the year.
Scoring	<p>Each boat will be scored for every completed race in each of the year's <i>Individual Series</i> for each class as follows:</p> <ul style="list-style-type: none"> • Races in series marked in the schedule as "Counts for the RBYC Overall" shall be scored • Races in series that were void shall not be scored <p>The Low Point scoring system of RRS Appendix A shall apply no scores excluded.</p>
Prizes	Prizes will be awarded to the first three boats in each class for the Overall Series.
Social	Prizes for all series shall be awarded at the Annual Prize-giving at R.B.Y.C. on November 30 th , 2012 at 18:30hrs.
